ADOPTION OF AGENDA (060720) Mrs. Hopewell moved, seconded by Mrs. Johnston, to adopt the agenda of the special meeting of the Indian Hill Board of Education, as amended, to include an employment recommendation for Laura Monahan, Eric Bass, Donna Collins, Kimberly Cupp, Susan Hannah, Beth Jackson, Barbara Jacobs, Patricia McCue, and Amy Stine and several supplemental contracts, and tuition reimbursements for Mark Richardson, Steven Seeger, and Jennifer Stidham as well as additional invoices requiring Board approval prior to payment. CORRESPONDENCE AND ANNOUNCEMENTS – Mr. Sharp thanked Mrs. Kress, attending her last Indian Hill Board of Education meeting as the Elementary School Principal, recognizing her efforts during these past twelve years with the District on behalf of the thousands of children (and their parents) who have been enrolled at Indian Hill Elementary School. Through her leadership, children have received a strong academic experience which will serve them well as they progress through the balance of their school years at Indian Hill and beyond.

SUPERINTENDENT'S REPORTS - Dr. Knudson introduced Mrs. Cynthia King, immediate past president of the Indian Hill Boosters Association, who discussed a proposed Pavilion Project for the grounds near Tomahawk Stadium. Mrs. King reported the Boosters' interest in providing a pavilion near the entryway at Tomahawk Stadium and indicated a contribution of \$100,000 for the construction of the basic structure without electricity (although conduit would be placed), and without fixed picnic tables. The Boosters have portable tables and grills which could be used in this area for the three major Booster events during Fall Sports Season. The Estimated Cost of the Project is \$107,330 and includes a \$16,000 contingency. This Project has been considered for the past three years and Booster funds are now in place to make this project move forward. If the Board approves this project, then the next step would be to seek Village Planning Commission approval in August.
