CORRESPONDENCE AND ANNOUNCEMENTS – Dr. Miles began with The Ohio School Boards Association recently notifying him that Kim Lewis, Board of Education President, has achieved a 10-year milestone in School Board service. We wanted to take a moment to recognize Mrs. Lewis for this significant achievement – a decade of service to our students, staff, and community. For the past ten years, you have been an influential voice guiding our District to new heights in academics, arts, and athletics. Most do not fully realize the tremendous investment of time and energy required to be a successful member of the Board of Education. We thank you for your service, leadership, patience, and persistence. Kim Lewis, you exemplify Enduring Excellence!

Indian Hill High School Junior Rama Sardar will represent Cincinnati, Ohio, as a National Youth Correspondent at the 2019 Washington Journalism and Media Conference at George Mason University in July. Rama will join a select group of students from throughout the United States for an intensive study of journalism and media. Rama was chosen based upon academic accomplishments and a demonstrated interest in journalism and media studies. National Youth Correspondents participate in hands-on, experiential learning through decision-making simulations that challenge them to solve problems and explore the creative, practical, and ethical tensions inherent in journalism and media. The experiential portion of the program is complemented by speakers who are well-known leaders in the media community. Presenters include prominent journalists, CEOs of major media outlets, researchers, and recent college graduates successfully entering the field. We know you will represent Indian Hill High School and the Indian Hill School District with class.

On Saturday, March 9, Indian Hill High School won its 6th Mock Trial State Championship! In the final analysis, Indian Hill swept all five ballots from the judges and won by 40 points against last year's defending state champions. Over the course of the tournament, Indian Hill High School took 16 of 17 total ballots and 9 of 10 awards. We also faced a previous state champion in all five rounds (something that no team has had to do since our first title in 2009). Now that this group has won a World Championship and a State Championship, they are heading to Athens, Georgia, in May to try to win Indian Hill's first National Championship. We wish you the very best!

Richard Bethel – through his 15 years of service in helping to create a magical experience for our Elementary School students during Pioneer Days has helped craft countless memories for our children. A father to two Indian Hill High School graduates – Sean and David – Mr. Bethel began his service to our children 40 years ago as a soccer coach; he served as the president of the Indian Hill Recreation Commission; he spent four years as a member of our Indian Hill Board of Education; he continues to volunteer for our District helping to manage the Indian Hill Middle School Gym during community hours. And, while he \*said\* he retired from Pioneer Days \*last year\* - we were all grateful to see him back around the campfire this school year ... and we hope to continue to see him for many years to come helping to write those memorable chapters of childhood. Mr. Bethel – thank you for your years of service to our students; thank you for being a true partner in education.

Keith Faber, Auditor of State, recently informed us that the Indian Hill Exempted Village School District is a recipient of the Auditor of State Award. This award is given to those entities that file timely financial reports in accordance with Generally Accepted Accounting Principles, as well as receive a clean audit report. The clean audit report means that the District's financial audit did not contain findings for recovery, material citations, material weaknesses, significant deficiencies, Single Audit findings, or any questioned costs. So tonight, we recognize the team that works so diligently to provide this commitment to accountability and service: Mick Davis, Beth Caudill, Tari DePoy, & Linda Woolridge.

SCHOOL SUPPORT GROUP ANNUAL FUNDRAISING REPORT – The Board was presented a summary of school support group fundraising for the last fiscal year. Our District remains so thankful for the numerous groups that continue to support our students and staff. Groups such as our PTO, Boosters, After Prom Committee, and Party on the Hill Committee continue to provide wonderful support for our District.

<u>PUBLIC HEARING AND FIRST READING OF THE 2020-2021 SCHOOL CALENDAR</u> - Ohio Revised Code 3313.48 asserts that prior to adopting a school calendar, the Board of Education shall hold a public hearing on the school calendar, addressing topics that include, but are not limited to, the total number of hours in a school year, length of school day, and beginning and end dates of instruction.

Thus, we will conduct a public hearing this evening and the first reading of the 2020-2021 school calendar.

Overall, the number of days in the 2020-2021 school calendar remains unchanged from the 2019-2020 school calendar.

- The first day of school for students is scheduled for Wednesday, August 19.
- The first semester concludes Thursday, January 14.
- The last day of school for students is scheduled for Thursday, June 3.
- This draft also retains a three-day Thanksgiving break, a two-week winter break in December/January, and six school days for spring recess from March 22 29.
- Staff development days are scheduled for August 18, September 4, October 16, and February 12.
- Two work days for teachers are scheduled for August 17 and June 4.
- Scheduled hours of instruction are well in excess of state minimum requirements. A minimum school year is now defined by hours at least 683 hours for <sup>3</sup>/<sub>4</sub> day kindergarten, 910 hours for students in grades 1-6, and 1,001 hours for students in grades 7-12. The calculated length of each school day varies slightly by building and grade due to provisions for calculation provided by the Ohio Department of Education. The length of each school day currently ranges from approximately 4.50 hours to 6.33 hours.

Following the review of comments provided this evening, we plan to present the second reading of the 2020-2021 school calendar at the May meeting or at a special meeting of the Board of Education more than 30 days from now. We have also posted the draft calendar online and will review and consider all feedback received.

At this time, Dr. Miles opened the public hearing and asked anyone wishing to address the Board of Education related to the draft of the 2020-2021 school calendar to please approach the podium, state your name, role, and provide comments. There were no public comments at the meeting. At this time, Dr. Miles closed the public hearing. Again, the second reading of the 2020-2021 school calendar will be provided at the May meeting or at a special meeting of the Board of Education more than 30 days from now.
