PUBLIC COMMENTARY -

Katie Foster discussed the mask policy. Ms. Foster submitted the following for inclusion in the minutes as part of public commentary;

Joyful, silly, and smart are words my husband and I would use to describe our six-year-old son. He is a child who knows no stranger, genuinely loves everyone he comes across, and is obsessed with cars. The world is his oyster, and he loves being an active participant in life! He loves to play, explore, and tell knock-knock jokes--his favorite being one about an interrupting chicken.

If you were to meet our son, you would think he's a typical child, but on the inside his windpipe and bronchial tubes are partially collapsed all the time. They collapse 100% when he coughs. Our son has a "hidden" disability called Tracheobronchomalacia. It is a rare and incurable airway disorder that can potentially be relieved, but not cured, by a series of highly specialized and complicated surgeries. Despite this severe airway disorder he does not qualify for a mask exemption. In fact, wearing a mask is one of the easiest ways to protect his airway and ensure he can be in school.

As I sit in a dark, cold, and cramped hospital room writing this while also watching machines read out a myriad of information during my son's third sleep study in his six years of life, I wonder what it must be like to have a "typical" child. It must be freeing to not sit and stare at a pulse/oximeter all night when your child has a "little cold" or watch to make sure your child's chest rises and falls, not because that's "what all parents do" but because there's a very real possibility that your child has completely stopped breathing in the middle of the night.

My son doesn't just get a two-day cold, he gets a two-week cold because of his airway disorder. This means that every little cold he gets is trapped deep down in his lungs and almost always turns to pneumonia. Now imagine having a child with this condition during this global pandemic and you can maybe understand a fraction of the terror we feel daily in making basic decisions like, should my son go play outside with friends?

Other than chronic lung disease, during COVID there have been no limitations on my son's ability to participate in school or extracurricular activities, except one: he must be around others that mask to protect his

airway. This means when a school has a universal masking policy for the classroom, but fails to require masking during high risk activities like gym and music along with recess, after school activities, and has only a few mitigation strategies during lunch, a child like ours has to sit alone in an alternate space to eat. He has to sit alone in the hallway by the front office of the primary school with a sensory bin during gym and music while his classmates have fun and learn. To add insult to injury, his parents are told after school activities like CAPA hosted by the PTO are "not a good fit" because masking is no longer required after school hours. Each of those things are daily realities for our kindergartener. But why?

Last year we watched this school district do a remarkable job of keeping children, faculty, and staff safe all year. It never shut down once because of its strong masking policy and mitigation strategies. But now, despite a more highly contagious variant of Covid circulating, one that is more dangerous for children, our district is suddenly dropping all those tried and true mitigation measures. Why?

Does my child's school district truly value political pressure over the lives of their students, faculty, and staff? That's certainly how it feels from our perspective.

And then there is the option of virtual schooling. If you were told your child could either learn in-person (which studies have shown to be a healthier environment for success), or stay at home with no social interaction, learning only math and reading, what would you choose? Forcing a child to have an inequitable education because of a God-given medical condition or disability is both unacceptable and illegal.

The one thing that can protect our son, and so many other children like him in this district, is the small "ask" of wearing a mask at all times indoors. That's it. If all his classmates wear a mask in gym and music, our son can finally participate fully in school without risking his life. If all his classmates wear a mask in the classroom, he can receive the equitable education he is entitled to.

That's it, just a mask. Just a mask until he and all children under 12 are able to receive full vaccinations. A piece of cloth to save a life. How could that even be a second thought for anyone?

Dan Horton discussed the mask policy. Mr. Horton submitted the following for inclusion in the minutes as part of public commentary;

Dan Horton, Raiders Run Road

This past year and a half have been trying for everyone. Thank you for your leadership, service to our schools and listening to the science behind successful Covid mitigation. Your efforts are working. Despite the Ohio seven-day average approaching 7,000 cases per day we are still in school.

My wife and I have 3 children – one each at the primary, elementary and middle schools. Emma, our youngest, in the primary school, has Down Syndrome and several health complications.

As an infant Emma was intubated for two months and then survived a 45-minute cardiac arrest at Cincinnati Children's. Since then, she has had a repaired heart, a tracheostomy and G-tube placed, dozens of tests and procedures, and receives at-home care from us, her parents. Emma has overcome more in her almost 8 years of life than most people do in their entire lifetimes. Yet, she persists and brings joy to everyone she encounters. However, it can take a village to support someone with complex medical needs and Emma is relying on this village to keep her as safe as possible.

Earlier this month, a Stanford and Yale University, large, randomized study on mask effectiveness conclusively found that masks impede the spread of Covid-19. The science is clear – masks work and keep kids in school, which is what we all want, and far outweighs the minor inconvenience of a child wearing a facial covering. What's more we have seen that children are not wholly unaffected by Covid. As few as 1 in 20 will have long Covid symptoms, and some European studies have shown more.

Emma's two siblings know that wearing a mask better protects them, their sister, their teachers, bus drivers and classmates. They know that they are a part of a larger community, of which they are stewards. This is a valuable life lesson that we want to impart on our children and is going to develop their empathy. Wearing or not wearing a mask to combat this novel virus can mean the difference between severe illness or worse for someone else and even them.

What's the price our community is willing to pay if we get rid of mask mandates, which work most effectively when everyone wears them? One student with long COVID? Two? God forbid, a student who gets admitted to the hospital? Some might respond "look at the percentages" of kids who are not affected by it. Do we want to say that to the parents of the child who is? I've seen my child on the brink, and I am confident that no one here would want that for any child, and especially not for one in the Indian Hill community.

Lastly, I urge the board to go and walk through the classrooms, looking specifically at desk placement. It has been communicated that three feet distance is being followed in all areas that is possible. But this is not what we've seen in any of the three buildings. It's clear that we need a layered approach – masking, filtration and distancing – for delta. The more layers we have, the less chance virus gets through to our kids. Thank you.

1. Weekly Caseload #s
2. Weekly Quarantine #s
3. Vaccine report%
4. Percentage of students and staff reporting having had positive cases of Covid and take into consideration the following
5. CDC current policy
6. OOH current policy
7. HCPH school guidance
8. TriHealth partner input
9. Cincinnati Health Collaborative input
10. AAP guidance

on a bi-weekly basis to evaluate the extension or removal of masking requirements indoors for the identified grade levels. These guidelines will be considered for Grades K-7 once vaccinations become available to our students under the age of 12, or when caseloads in the district are below ()
