**CORRESPONDENCE AND ANNOUNCEMENTS**

The Indian Hill School District congratulates the Indian Hill High School Academic Team for earning top 20 in the nation during the Small School National Championship Tournament held in Chicago in May.

We celebrate the Indian Hill Television Network (IHTN) for earning a record 15 Blue Chip Awards during the annual ceremony in May. This year had the largest number of finalists in our program's history spanning 26 years. Indian Hill had 37 programs nominated, 22 programs that made it to finals, with 15 of those finalists earning awards. Winning producers included the following Indian Hill High School students: Geno Cardosi, Daniel Chen, Nick Guinan, Wyatt Higgins, Chloe Hutton, Brian Jia, Henry Kohlen, Dhilan Minocha, Zachary Rosenbaum, Alex Rozakis, and Reesë Tuttle. In addition to the student-earned awards, Indian Hill Blue Chip Award winners also included three Indian Hill teachers: Ricardo Hill, Tom Millard, and Susan Savage. Indian Hill Athletic Coordinator Julius King, Athletic Trainer Terri Konte, and Chief Communications Officer Heather Higdon also won.

We congratulate IHPS teacher Jennifer Theiss for receiving the George B. Chapman Award for Excellence in Mathematics Education, in association with the Martha Holden Jennings Foundation. Theiss was selected by a committee of fellow educators to be the winner of this award. The recognition ceremony will be held at our annual Jennings Educators Retreat on July 27-28, 2023.

We celebrate the Indian Hill Elementary School students selected for the People's Choice Award during the annual Design LAB Exhibit. The student designers/architects included Jasmine Arul, Grace Cooperrider, Frankie Hall, Eva Jha, and Nicholas Miller. Design LAB pairs local professionals with educators to guide students through a real-world, themed design problem, emphasizing the development of: research, critical thinking, financial literacy, problem solving, verbal and visual communication, creative expression, collaborative team-building, STEM and presentation skills. The students created a project called Wonderland Amusement Park, which was on display during the design show during the end of May in Northern Kentucky.

This resolution to declare transportation impractical for certain identified students is presented pursuant to the requirements of Ohio Revised code 3327 and the procedures set forth by the Ohio Department of Education. The resolution follows careful evaluation of all other available options prior to consideration of impracticality.

The Superintendent of Schools, Kirk Koennecke recommends that the board of education adopt the following resolution:

WHEREAS the student(s) identified below have been determined to be residents of this school district, and eligible for transportation services; and

WHEREAS after a careful evaluation of all available options, it has been determined that it is impractical to provide transportation for these student(s) to their selected school(s); and

WHEREAS the following factors as identified in Revised Code 3327.02 have been considered:

1. The time and distance required to provide the transportation;
2. The number of pupils to be transported;
3. The cost of providing transportation in terms of equipment, maintenance, personnel, and administration;
4. Whether similar or equivalent service is provided to other pupils eligible for transportation;
5. Whether and to what extent the additional service unavoidably disrupts current transportation schedules;
6. Whether other reimbursable types of transportation are available.

WHEREAS the option of offering payment-in-lieu of transportation is provided in Ohio Revised Code: Therefore, be it

RESOLVED that the Indian Hill Exempted Village School District Board of Education hereby approves the declaration that it is impractical to transport the students identified herein and offers the parent(s)/guardians(s) of students named on the attachment, payment-in-lieu of transportation.
