Regular Meeting of September 17, 2024

A regular meeting of the Indian Hill Exempted Village School District was held on Tuesday, September 17, 2024, at 6:30 p.m., in the Indian Hill Community Room, 6855 Drake Road, Cincinnati, OH 45243 in accordance with notices sent to each member. Mr. Marx, President, called the meeting to order at 6:30 p.m. and roll call showed the following members as present:

ADOPTION OF REGULAR BUSINESS MEETING AGENDA (092401) – Mr. Sumerel moved, seconded by Mrs. Singh, to adopt the agenda of the regular business meeting of the Indian Hill Board of Education. All members present voted aye. Motion carried.

PLEDGE OF ALLEGIANCE – Indian Hill Elementary students Raegan Wells, Alice Kommer, Ella Snow and Emily Lemmon led the recitation of the Pledge of Allegiance.

PUBLIC COMMENTARY

Darbi Boddy read excerpts from several books, including “*Water for Elephants*” and “*Slaughterhouse 5*”. Ms. Boddy expressed concerns regarding the presence of educationally unsuitable and pervasive vulgar materials in our schools. She urged the board to take action by forming a committee to review these books using [ratedbooks.org](https://www.ratedbooks.org) to ensure a safe and appropriate educational environment.

Amy Stotzer expressed concerns about the state of our media center programming. Ms. Stotzer stated that Indian Hill Schools, which recently received 4.5 stars on the Ohio School Report Cards, is falling behind other local districts that scored five stars, particularly in the area of student progress. She stated that research shows that strong library programs correlate with better student achievement, yet our high school has significantly reduced its collection, and the middle school library is currently closed to students. Ms. Stotzer urged the district to address these issues by maintaining diverse and accessible library resources, as well as ensuring that all students have the opportunity to access library facilities.

Tripp Shubert expressed his concerns about the district's media center situation and recent performance scores. Mr. Shubert stated he was surprised that the media center issues raised since Labor Day have not yet been addressed, and would like more information on the plans for improvement. He expressed that he understands performance scores may not tell the full story, they do measure progress and should be taken seriously. He's eager to know what initiatives the district plans to implement to enhance performance and what the current status of our programs is.

Mark Stotzer expressed concerns about the school scores, especially since ten local districts are outperforming Indian Hill despite our funding, which was meant to maintain a world-class education. Additionally, he expressed concern that the middle school media center is not open, and there seems to be no urgency to address this issue, despite the bond issue promising to support all student services. The high school also lacks a comprehensive library collection, which is critical for our entrepreneurship program. Lastly, he questioned the efficiency of district resources being spent on social media and content creation instead of focusing on student education and improvement.
